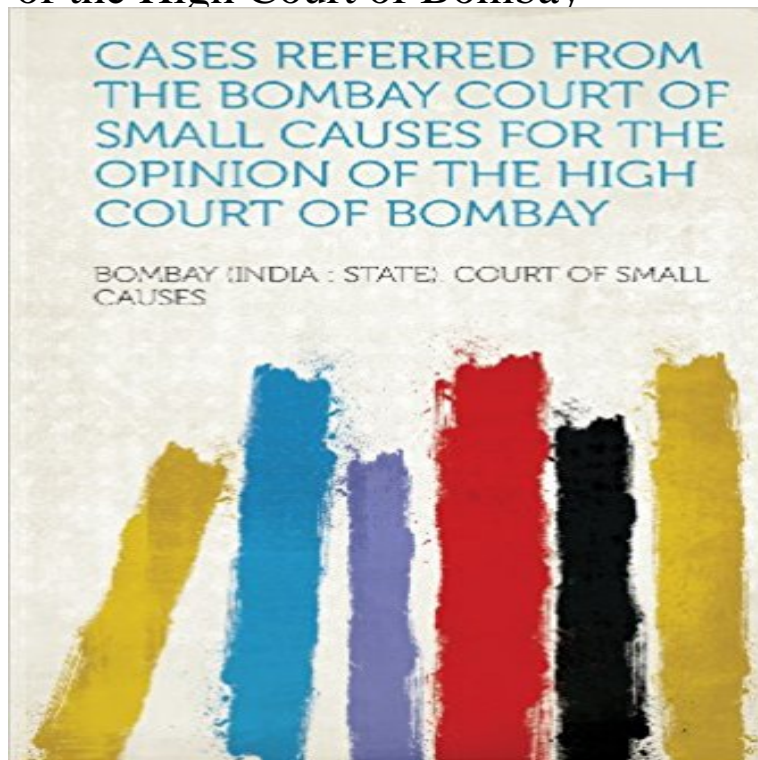


## Cases Referred from the Bombay Court of Small Causes for the Opinion of the High Court of Bombay
