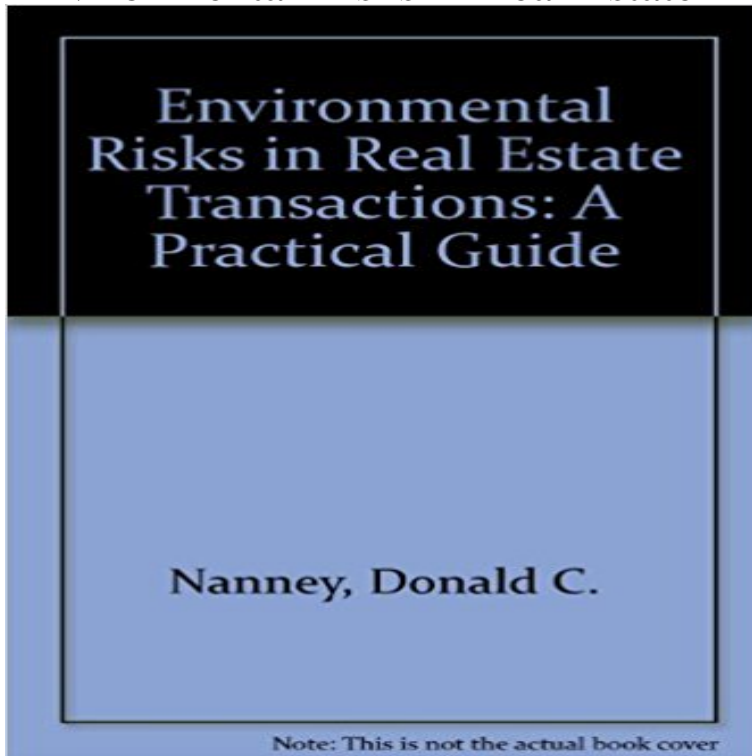


Environmental Risks in Real Estate Transactions: A Practical Guide
