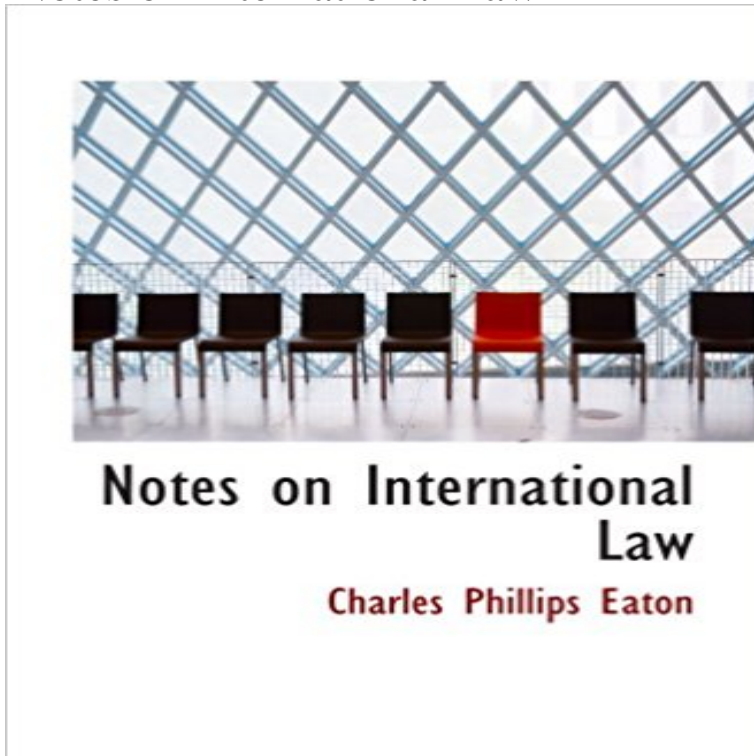


Notes on International Law
