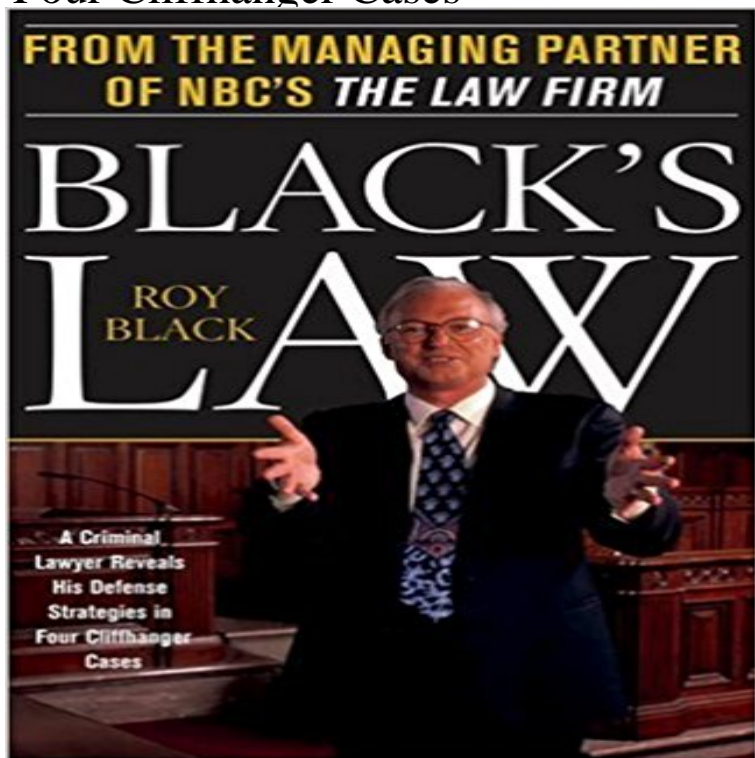


# BLACKS LAW: A Criminal Lawyer Reveals His Defense Strategies in Four Cliffhanger Cases
