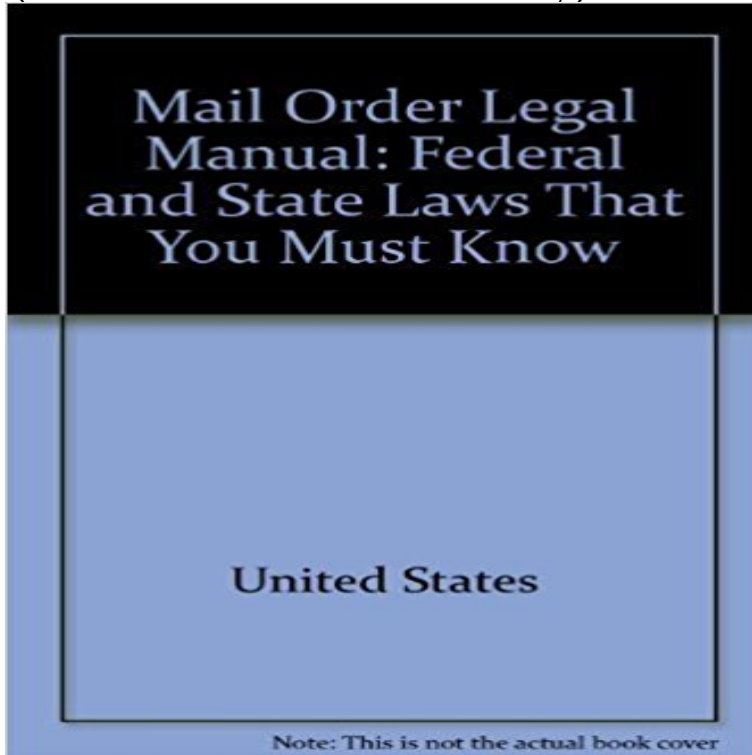


## Mail order legal manual: Federal and state laws that you must know (Successful Business Library)
